Exhibitor Information

General Information:

The book display will be sited in the Conference Center of the Marriott Eaton Center where the program sessions are being held. Publishers may choose to reserve individual Exhibit Tables or to place books in the Publishers Combined Display.

Services and Conditions:

1. Exhibitors and Publishers Combined Display vendors whose contracts are received by July 12, 2002 will be identified prominently in the program book distributed to all meeting participants.
2. Exhibitors with Exhibit Tables may display their own catalog. Order forms may be used at the Combined Display and at Exhibit Tables.
3. All display copies in the Combined Display become the property of the ASOR Annual Meeting.
4. ASOR reserves the right to determine whether exhibits are in keeping with the character of the Meeting.
5. Set up of Exhibit Tables and the Combined Display will probably take place 5:00pm-7:00pm Wednesday (Nov. 20). Details will be confirmed nearer the time.
6. Exhibit hours will be 8:00am-5:00pm on Thursday and Friday (Nov. 21 and 22) and 8:00am-12:00pm Saturday (Nov. 23). If exhibitors need to leave early to attend the AAR/SBL meeting there is no penalty.
7. Exhibit Table vendors are responsible for removing materials by 4:00pm Saturday (Nov. 23).
8. Only Exhibit Tables vendors with a representative present may sell on site.
9. For publishers in the Combined Display who have provided blank order forms, exhibit staff will encourage meeting attendees to send order forms directly to the publishers.

Deadline:

Contracts for publishers who wish to be listed in the program book must be received in the ASOR Publications Office by July 12, 2002. All other reservation contracts must be received by November 1, 2002.

Exhibit Fees (in \$US):

Exhibit Tables (as available on a first-come-first-served basis): 3' x 6' = \$140 (Minimum two). This includes a 1/4 page ad in the program book (if this fee is paid and copy is supplied by July 12, 2002) and complementary registration. Larger advertisements will be accepted for the program book subject to space being available. Please contact the ASOR Publications Office at the address shown for details of availability and rates
